#### About the Magisterial Services Library

Papua New Guinea's (PNG) Magisterial Services Library is responsible for acquiring, organising and making accessible the necessary legal information resources to Magistrates working in PNG to assist them with performing their judicial work.

There are currently about 90 Magistrates who work across 22 provincial centres and some of the 89 District Courts in PNG.

Prior to 2003, the National & Supreme Court Library of PNG provided legal library services for the Magistrates and provided this service by way of establishing law collections in Provincial & District locations.

However, today there are 5 small libraries located in 5 provincial locations. The Magisterial Services Library currently provides its services through these 5 libraries by utilising electronic and print resources to continue providing necessary legal information to their clients.

#### **Choosing Liberty**

The purchase of <u>Liberty</u> is one major step towards the library increasing its ability to acquire, organise and make accessible more legal information and resources to more of their clients spread out over a wide geographical area.
